The subject of the Application/Contract is the issuing of an electronic monetary medium– City Card (hereinafter the Application/Contract) including the electronic wallet of the Cardholder. The active electronic wallet serves to pay for transport and carriage on the Public Transport System in Hradec Králové, also on contract carriers and for the purchase of services or products at other subjects integrated in the City Card project.

The contractual relationship between the Issuer and Cardholder comes into effect at the moment the City Card is issued with an active electronic wallet or time-limited ticket. With the acceptance of the Card, the signed form Application/Contract changes into a Contract of issuing the electronic monetary medium–City Card. Conditions for issuing and using contactless chip cards (hereinafter the Conditions) are an integral part of this Contract. Unless specified otherwise, the legal relations established from the Contract between the Issuer and Cardholder are regulated in accordance with Act No. 513/1991 Coll., the Commercial Code as amended.

The Cardholder agrees that the data, which they have provided to the Issuer the Transport Company of the city of Hradec Králové,a.s., as the administrator of personal data in accordance with Act No.101/2000 Coll., on protecting personal data, may be used by the City Card Issuer, and all other contractual partners, who will also offer use of this card (e.g. cultural, sports facilities); for the entire duration of the City Card project.

Declaration: With his/her signature of the Application/Contract on issuing the City Card, the Cardholder confirms that all data has been stated truthfully, that he/she has read the Conditions thoroughly and understood them, agrees with them and has not signed the Application/Contract in duress or under any disadvantageous conditions.
